### Davis Family Papers (1824-1951, bulk 1839-1896)

**Introduction:** The Davis Family Papers include diaries, letters, deeds, and receipts kept by Robert F. Davis, Jr. and his family, as well as biographical and genealogical information on three generations of the Davis family collected and donated by Robert F. Davis III in the mid-twentieth century.

#### Biographical Sketch of Robert F. Davis

Robert F. Davis Jr. was born in 1839 in DeKalb County, Georgia. A life-long DeKalb resident, Davis served in the Confederate Army as a member of Company E, 7<sup>th</sup> Regiment, Georgia Volunteer Infantry, Army of Northern Virginia (“DeKalb Light Infantry”). He was made a 3<sup>rd</sup> Corporal on May 29, 1861, elected a Jr. 2<sup>nd</sup> Lt. on May 12, 1862, and a 2<sup>nd</sup> Lt. on November 9, 1862. He surrendered at Appomattox, Virginia on April 9, 1865. After the war, Davis returned to DeKalb County, where he lived until his death in 1899.

#### Description

The Davis Family Papers are primarily composed of correspondence, receipts, and pocket diaries kept by Robert F. Davis Jr. These small books contain diary notes, memoranda, farm accounts, and weather observations made over a 20-year period (1867-1887). The collection also includes land deeds, receipts, and various documents concerning other Davis Family members, as well as biographical and genealogical information on three generations of the family. Relatives specifically mentioned include Moses, E.A., Anne, Clara, and Olivia Davis as well as Robert Sr., Robert Jr., and Robert III.

#### Organization and Arrangement

The first box contains biographical information and family trees, receipts for farm expenses and money orders, correspondence from Robert F. Davis Jr., and deeds to Davis

family land. The second box contains 12 small books, or pocket diaries, of farm expenses and other daily memoranda for the years 1867-1887.

While the collection appears to have been organized upon accession in 1979, the Davis Family Papers have been reorganized into five general categories: biographical information, land deeds, correspondence, expense records, and pocket diaries. Within each category, folders have been arranged in chronological order. Two folders (files 34 & 35) were discovered to be empty and the accession records contained within have been removed and filed. Original file numbers have been retained and are recorded beside new numbers in the folder list.
